Your \$100\* RPAC investment works at all three levels of government.

- \$30 funds REALTOR® friendly candidates for United States Congress

15% of Investment to state Issues Mobilization Fund. The remaining 85% of Investment is shared: 30% to NAR | 50% to SDAR, | 20% to Local Funding

- \$60 funds effective issues campaigns and educational efforts related to state issues.

\*For contributions to multiple categories, separate checks must be written to the appropriate category name.

**Remittance Reminder:** All contributions collected at the board level must be transmitted **to the state PAC** within the applicable 10- or 30- day time limit from the "date of receipt." The "date of receipt" begins when the contributor gives the contribution check to the solicitor, and ends when the contribution is received by the **state PAC**.

**DISCLAIMER:** Contributions are not deductible for income tax purposes. Contributions to RPAC are voluntary and are used for political purposes. You may refuse to contribute without reprisal and the National Association of REALTORS® or any of its state associations or local boards will not favor or disfavor any member because of the amount contributed. 70% of each contribution is used by your state PAC to support state and local political candidates. Until your state reaches its RPAC goal, 30% is sent to National RPAC to support federal candidates and is charged against your limits under 2 U.S.C. 411a; after the state PAC reaches its RPAC goal it may elect to retain your entire contribution for use in supporting state and local candidates.
